

# Attention: Van Buren County Residents

## Dog Licensing Information

Michigan Compiled Law 287.266 requires that all dogs over 4 months old **MUST** have **BOTH** a current rabies vaccination **AND** a current dog license. Michigan Law 287.267 requires that the tag must be worn by your dog. 2011 Dog Licenses must be obtained by March 1, 2011, or by the time a puppy is 4 months old. Newly acquired dogs and dogs of new residents will be charged the regular rate if licensed within 30 days of acquiring or moving into the county.

**WARNING--There are criminal and financial penalties for failure to properly vaccinate and license your dogs. Non-compliance is costly.**

### Instructions for dog owners:

1. Make sure your dog is currently vaccinated for rabies. Your veterinarian will give you a "Certificate of Rabies Vaccination" showing the expiration date for the vaccination. You also may attend one of the special clinics held at various locations in the county, where your dogs can be vaccinated and your license applications processed. Watch your weekly shopping paper for details.

**Your dog's vaccination must have 30 days remaining on it in order to purchase a 1-year license. If your dog's vaccination expires AFTER April 1, 2013 you may purchase a 3-year license.**

2. Complete the "Application for Dog License" on the reverse side as completely as possible. Use a separate form for each dog you own. Additional application forms are available at the locations mentioned below, or by calling the County Treasurer at 269-657-8228 or at [www.vbco.org](http://www.vbco.org).

3. Mail **BOTH** the "Certificate of Rabies Vaccination" and the completed "Application for Dog License", along with the proper license fee amount, to the VAN BUREN COUNTY TREASURER. **Or, if you prefer, (and for fastest service)** you may apply for the license in person at the Van Buren County Treasurer's Office. You may also apply in person at any of the offices listed below.

4. Upon receipt of required documents and fee, your license and tag will be mailed to you. Your "Certificate of Vaccination" will be returned to you. If you don't receive these items within 60 days, please contact the VAN BUREN COUNTY TREASURER at the address below.

5. Microchip implantation and registration is available at most licensed Veterinarian's offices. Please contact your Vet for details. (Published pursuant to PA 551 of 2006)

6. The State of Michigan maintains a statewide tattoo identification registry for dogs. Contact the Department of Agriculture at (517) 241-2748 for more information.
