Motion by Millek to approve agenda as presented for August 6, 2009. Second by P. Tomlinson. Voice vote, all yes. Motion carried.

Motion by Millek to accept the minutes of July 2, 2009 as presented. Second by P. Tomlinson. Voice vote, all yes. Motion carried.

Jennifer Carver, Executive Director for Senior Services presented to the Board and the Audience a presentation on the need for Services and Programs for Seniors. The objective is to create one central place where all information is available. Various services would include an Information and Assistance Center, In-Home Care Assessments, Care Watch Care Management Services, Affordable In-Home Care, Congregate and Home Delivered Meals through SNS and many more. The Senior Services are asking for a proposal for your approval to levy a tax of .25 on your property and hope to be on the August 2010 Ballot. Clerk Report: Clerk had informed the Board that she had inadvertently overlooked the Mileage rate from our Budget Planning Meeting and had been using the old rate of 0.505 since April 2009. The current IRS rate is .55. The Clerk checked with Michigan Township Association and was informed that using the lower rate for reimbursement is not a problem. Millek informed the Board and audience members that the former Board made the decision to go with the current IRS quote rate, so from August forward , we will reimburse mileage at the current rate.

Motion by P.Tomlinson for Fay Dorr to be on signature cards at banks. Second by Millek. Voice vote, all yes. Motion carried.
